

**SIGNATURE BLENDS**  
**CONTEST**  
**OFFICIAL RULES AND REGULATIONS**

1. TO ENTER the SIGNATURE BLENDS contest (the "Contest") simply visit the web site located at [www.globeandmail.com/SignatureBlends](http://www.globeandmail.com/SignatureBlends), click on the Contest page, complete and submit your entry by following the instructions found on the site. In the event of a dispute, entries received on-line shall be deemed to be submitted by the "Authorized Account Holder" of the email address submitted at the time of entry. "Authorized Account Holder" is defined as the natural person who is assigned to an e-mail address by an internet access provider, on-line service provider, or other organization (e.g. business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. All entries must include your first and last name, address, email address, age and ten digit day time and evening telephone number. Limit of one (1) entry per individual per day. If it is discovered that you attempted to enter more than once per day, all your entries will be void. Illegible entries are ineligible. Contest starts at 1:00 a.m. Eastern Time ("ET") on Friday, May 09, 2008 and closes on Sunday, June 01, 2008 at 11:59:59 p.m. Eastern Time ("ET") (the "Contest Period"). 2. The contest sponsors are CTVglobemedia Publishing Inc. and Foster's Wine Estates Canada (hereinafter referred to as the "Contest Sponsors").

To enter and to be eligible to win, entrant must be a legal resident of Canada and be of legal drinking age in the state of California Employees and their parents, siblings and children, and persons domiciled with an employee of any of the Contest Sponsors, their agents, parent, affiliated or related companies, subsidiaries, divisions, prize sponsors, and promotional and advertising agencies and administrators, are ineligible to enter. A winner of a The Globe and Mail contest within the three (3) months preceding the start of this contest (including persons designated by such winners to take ownership of prizes) and persons domiciled with a winner are not eligible to enter.

Prize winner and his/her travelling companion are solely responsible for all costs not expressly described herein including, without limitation, applicable taxes, fuel/currency surcharges, ground transportation, meals, beverages, room service, gratuities, merchandise, telephone calls, insurance together with any required travel documentation, and all personal expenses of any kind or nature, together with any applicable overnight

layover. Departure dates and hotel accommodation are subject to availability and change without notice or compensation. Prize winner and his/her travelling companion are also solely responsible for all costs incurred to and from the Departure Point as the Prize originates and terminates there. 6. On or after Tuesday, June 03, 2008 at approximately 2:00 p.m., a random draw for the Prize will take place at K.D. Black and Company, Toronto, Ontario from among all eligible entries received during the Contest Period. The first entry drawn will be eligible to win the Prize. The odds of winning a Prize will depend upon the total number of eligible entries received during the Contest Period. K.D. Black and Company, acting reasonably, will attempt to contact potential winner by telephone within two (2) business days after the draw. In the event the potential winner cannot be contacted within 2 business days after the draw, he or she will be disqualified and an alternate potential winner will be drawn. Proof of identification must be provided upon request. In order to be declared a winner, potential winner must first correctly answer, unaided, a time limited mathematical skill testing question administered by K.D. Black and Company.
