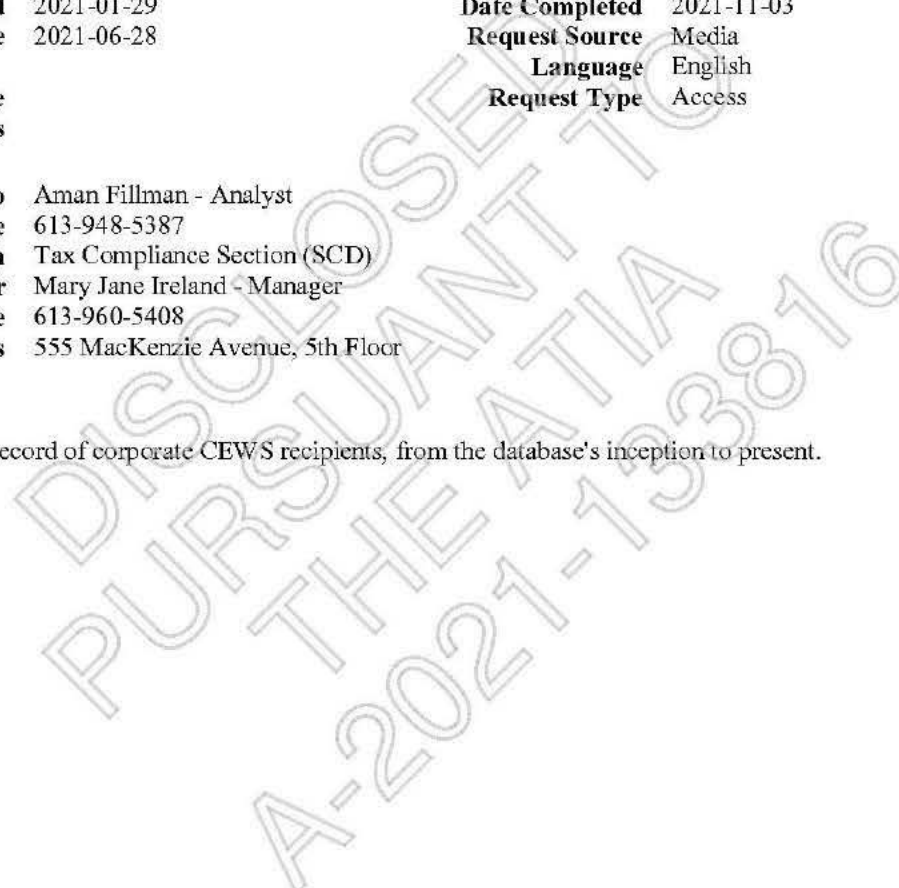

It may be worthwhile to eventually ask the requester to abandon 1 file (suggest abandoning this one as asking for too much information we aren't allowed to provide).  When your research is done, please let me know and we will schedule a meeting to discuss our next steps regarding the two related files. CRA cannot retrieve or provide information without consent from the taxpayers. I explained that what the requestor is asking for in requests A-124534 & A-124624 goes beyond what we can legally provide. The requestor seemed to understand but was disappointed that we couldn't provide all the information they want. The requestor wanted to know why there was such a long delay in responding and I said that we were waiting for A-123465 to be processed and finalized and that it was a very large file and deals with a sensitive topic.  I let them know we received a similar request (A-123465) and we can provide a copy of that, which is a list of companies that received CEWS from March-December 2020. The requestor asked if it was in excel and I told them that we only process records in PDF format. I also said that we could provide a briefing note (informally) about the CEWS registry (A-124076) which explains why the requestor cannot receive everything they asked for. The requestor agreed to receive these records instead and asked that I explain everything in a formal letter and that they may appeal it.
