

RELEASE

WHEREAS Ms. Nicolette Lutz purchased medical marijuana from Organigram Inc. (“**Organigram**”) which is alleged to have contained chemicals not approved for application on the cultivation of marijuana plants under the *Pest Control Products Act* (Canada) (the “**Matter**”);

AND WHEREAS the Parties have come to an agreement whereby Ms. Lutz will release and hold harmless Organigram and the Released Parties (as defined below) from any and all liability and damages, if any, in consideration of a cash payment;

NOW THEREFORE THIS AGREEMENT WITNESSETH that in consideration of the payment of ninety-five dollars (\$95.00) and other valuable consideration, the receipt and sufficiency of which is hereby acknowledged by Ms. Lutz, Ms. Lutz covenant and agrees as follows:

1. FULL AND FINAL RELEASE

Ms. Lutz does hereby release and forever discharge Organigram Inc. and Organigram Holdings Inc., and each of its successors, administrators, assigns, affiliates and related companies, and its directors, officers, agents and employees, as applicable (the “**Released Parties**”), of and from all liability and indebtedness associated with the Matter and all actions, causes of action, damages, Matters, cross-claims and demands whatsoever, (including all damage, loss and injury not now known or anticipated but which may arise in the future and all effects and consequences thereof), and from all statutory Matters whatsoever, however and wherever arising, which Ms. Lutz had, now has, or which Ms. Lutz’s heirs, administrators and assigns or any of them hereafter can, shall or may have with respect to the Matter.

2. CONFIDENTIALITY UNDERTAKING

Ms. Lutz hereby further agrees and undertakes to protect in strict confidence, and not to use or disclose, any and all information relating to the terms and the fact of this Release. For greater certainty, the terms and content of this Release may not be disclosed by Ms. Lutz, including through social media posts of any nature or verbally to any third-party. For greater certainty, this document may not be reproduced or otherwise copied, cited, paraphrased or excerpted therefrom.

In addition, Ms. Lutz agrees not to reveal, disclose, use or cause to be revealed, disclosed or used any information or material with respect to the Released Parties which is injurious to any of the Released Parties’ interests and, without limiting the generality of the foregoing, Ms. Lutz expressly agrees not to make any public statement of any of the intellectual property, business affairs, policies or the like of the Released Parties without the express written consent of the Released Parties, directly or indirectly, in any respect.

3. NON-DISPARAGEMENT

The Parties agree that neither such Party nor its directors or officers or lawyers or agents, as applicable, shall, in any communications with the press or other media or any customer, client or supplier of the Company, or any of the Company’s affiliates, or any member of the public, criticize, ridicule or make any statement which disparages or is derogatory of any of the Released Parties or its affiliates or any of their respective directors or senior officers, as applicable.

For greater certainty, the obligations set forth in this Section 3 and Section 2 above include posting on any social media sites, including under any alias.

4. BENEFIT OF RELEASE, AGREEMENT AND UNDERTAKING

It is understood and agreed that this Release shall enure to the benefit of the Released Parties and shall be binding on each signatory hereto and each such signatory's successors, administrators, assigns, affiliates and related companies.

Ms. Lutz hereby declares that he fully understands the terms of this Release, has had the opportunity to obtain independent legal representation in connection with this Release and that he voluntarily accepts same for the purpose of making full and final compromise, adjustment and settlement of all Matters as aforesaid, whether arising by force of contract, at common law, or under applicable statutes.
