BANKRUPTCY APPLICATION

ROHIT SEHGAL (the "**Applicant**"), an individual residing in the City of Toronto, in the Province of Ontario, hereby applies to the Court that **MICHAEL ANTHONY WEKERLE** be adjudged bankrupt and that a Bankruptcy Order be made in respect of the property of Michael Anthony Wekerle, of 287 Forest Hill Road, Toronto, in the Province of Ontario, and says:

1. That the said Michael Anthony Wekerle, has at some time during the six months preceding the filing of this Application resided at 287 Forest Hill Road, Toronto, in the Province of Ontario, within the jurisdiction of this Court.
2. That the said Michael Anthony Wekerle is justly and truly indebted to the Applicant as of November 26, 2014 in the approximate amount of US \$1,383,000.00 under a Promissory Note which was executed by Michael Anthony Wekerle in favour of the Applicant and which came due on or about October 20, 2014 on the sale of a property known as 195 Hudson St., Unit 2C, New York, New York in the United States of America.

3. That the Applicant does not, nor does any person on his behalf, hold any security on the debtor's property, or on any part thereof, for the payment of the said sum.

4. That Michael Anthony Wekerle has, within the six months next preceding the date of the filing of this Application, committed the following acts of bankruptcy, namely:


- (a) the debtor has made one or more fraudulent gifts, delivery or transfer of the debtor's property or of any part of it;
- (b) the debtor has made a transfer of the debtor's property or any part of it, or has created charges on his property that would under the *Bankruptcy and Insolvency Act* be void as a fraudulent preference;
- (c) the debtor has ceased to meet his liabilities generally as they become due.

5. That **Pollard & Associates Inc.** of the Town of Richmond Hill, in the Province of Ontario, is qualified to act as Trustee of the property of the said debtor and has agreed to act as such and is acceptable to the undermentioned Applicant:




