By entering this Contest, the entrants and participants automatically agree to accept and abide by these Official Contest Rules. All decisions of the Contest Sponsor with respect to any aspect of this Contest, including without limitation the eligibility of entries, are final and binding on all entrants in all matters as they relate to this Contest.

- 1. **Contest Sponsor**. The contest sponsor is The Globe and Mail Inc. (the "Contest Sponsor").
- 2. **Contest Period**. @GlobeStyle #Gifts Twitter Contest (the "Contest") begins at 12:01 a.m. Eastern Time ("ET") on December 4, 2014 and ends at 11:59 p.m. ET on December 15, 20134 (the "Contest Period").
- 3. **Eligibility**. To be eligible, you must be a legal resident of Canada, excluding Quebec, and be of the legal age of majority in that province or territory.
